Dear Parent

In accordance with CBSE Circular No. CBSE/COORD/2021 dated 11.2.2021, the Annual Examination for Classes 9 & 11 will now be conducted OFFLINE.

In these testing times, this will be another test for all of us as an attempt to return to normalcy. We, at SPS, have always appreciated the support that you have extended in all our endeavours and hope that it will continue through this initiative also. All the protocol for CAB (Covid Appropriate Behaviour) will be followed strictly within the school premises. Support at your end will go a long way in ensuring the efficacy.

The following points must be kept in mind while sending your ward to school on days [s]he has an exam:

- 1. Students must carry **TWO** copies of the "duly signed **Consent Form**". One copy is to be submitted by your ward in school on the first day the child appears for the exam and another copy is to be carried by your ward whenever [s]he comes to school. (Annexure I)
- 2. Students must:
 - i. Be in school uniform and carry School Id card.
 - ii. Wear mask 3 ply or surgical as per government norms, at all times.
 - iii. Maintain social distancing at all times.
 - iv. Report to allocated classroom for examination. The same will be updated regularly in the Student login Id on School Website.
 - v. Since movement from allocated classroom/sharing of stationery will not be permitted, carry all material required for his/ her exam.
 - vi. Follow COVID Appropriate Behaviour (CAB) protocol set up by the Government.
- 3. Annual Examination Datesheet Schedule and timings will remain same except for the specified changes mentioned below:
